
National Food Authority Accomplishment Report December 2017



MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of December 2017, NFA procured 1,067 MT of palay, which is 7.61% accomplishment of the month's target of 14,025 MT. The decrease in procurement level can be attributed to lower production output in rice producing areas specifically due to the ravage brought about by typhoons in the Visayas and Mindanao areas.



DISTRIBUTION

For the month of December, NFA distributed 59,948 MT of rice, equivalent to 99.94% accomplishment of the month's target of 59,985 MT.



PRICES

Based on the Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price posted an increase of P0.35 from last month's price of P18.51 to P18.86 for this month, NFA's buying price for palay is comparatively lower by P1.86/kg., compared to the prevailing commercial level. NFA's buying price for yellow corn, was lower by P0.05/kg., while for white corn, it is lower by P2.86/kg.

Both wholesale and retail prices of WMR and RMR posted slight increases of \$\text{P}0.08/kg\$. and \$\text{P}0.06/kg\$. in the wholesale level, \$\text{P}0.09/kg\$. and \$\text{P}0.05/kg\$. in retail level, respectively. Yellow Corn manifested a slight increase of \$\text{P}0.07/kg\$. in wholesale and \$\text{P}0.15/kg\$. in retail. White Corn on the other-hand, showed decrease of \$\text{P}1.87/kg\$. in wholesale, and \$\text{P}0.38/kg\$. in retail.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED RICE STOCK INVENTORY

As of December 31, 2017, NFA stock inventory of 2,128,942 bags (total rice equivalent – TRE) or 106,447.1 MT, is good to last for 3 days, based on the 2017 national daily rice consumption requirement of 31,463 MT.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS FOR THE MONTH OF DECEMBER 2017

The total volume of assessed NFA stored grains as of the end of December 2017 was 2,186,063.7 bags, composed of palay, milled rice and corngrains, presenting a decrease of 32.84% from the November 2017 volume of 3,254,857.2 bags. Stocks fit as food (rice) and feed (corn) represent 99.95% of the total assessed grains. Stocks for disposition were 673.6 bags (0.031%) composed of sweepings and partially damaged stocks, and 358.9 bags (0.016%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of December, NFA registered and licensed 561 applicants, 112 of whom availed of the two-year (2018-2019) advance-license scheme. Total R/L collections on grains business activities amounted to P469,652.45, which include collection from mobile licensing amounting to P136,610, and P180,455 from advance license collections. 148 metal plates were issued/sold for P29,600. The R/L fees activities already accomplished 120.79% of the annual targeted collection of P143M.

Other activities included the testing of packaging materials and label evaluation; heat penetration and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.
