
National Food Authority Accomplishment Report July 2017

MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of July 2017, NFA procured 104 MT of palay, which is 12.55% accomplishment of the month's target of 825 MT. The low procurement accomplishment can be attributed to the onset of lean month's period. Procurement likewise decreased compared to last months' 26.89% accomplishment.



DISTRIBUTION

For the month of July, NFA distributed 47,252 MT of rice, equivalent to 34% accomplishment of the target of 137,810 MT.



PRICES

Based on the Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price posted an increase of P0.13 from last month's price of P19.31 to P19.44 for this month, NFA's buying price for palay is comparatively lower by P2.44/kg., compared to the prevailing commercial level, compared to the prevailing commercial prices. NFA's buying price for yellow corn, was significantly higher by P1.10/kg., while for white corn, it is lower by P0.53/kg.

Both wholesale and retail prices of WMR and RMR posted slight increases of P0.21/kg. and P0.22/kg. in the wholesale, and P0.22/kg. and P0.14/kg., in the retail levels, respectively. Yellow and White Corn manifested a slight increase of P0.02/kg. and P0.17/kg. in wholesale level, but showed a decrease of P0.21/kg. and P2.60/kg. in retail level respectively.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of July 31, 2017, NFA had a stock inventory of 2,173,837 bags (total rice equivalent – TRE) or 108,691.85 MT, good to last for 3 days, based on the 2017 national daily rice consumption requirement of 31,463 MT.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS FOR THE MONTH OF JULY 2017

The total volume of assessed NFA stored grains as of the end of July 2017 was 2,384,994 bags, composed of palay, milled rice and corngrains, a decrease of 31.36% from the June 2017 volume of 3,475,054 bags. Stocks fit as food (rice) and feed (corn) represent 99.86% of the total assessed grains. Stocks for disposition were 3,252 bags (0.137%), composed of sweepings and partially damaged stocks, and 124.1 bags (0.005%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of July, NFA registered and licensed 1,982 applicants, 37 of whom availed of the two-year (2018-2019) advance-license scheme. Total R/L collections on grains business activities amounted to P2,834,423.62, which include collection from mobile licensing amounting to P661,658.62, and P42,295 from advance licenses. 512 metal plates were issued/sold for P102,400. The R/L fees amounting to P149,184,984.10 comprised 106.31% of the annual targeted collection of P143M.

For the month of July, FDC performed 32 physical and sensory evaluation, 92 chemical analysis, 82 microbiological, 1 contaminants and 23 micro analytical quality evaluation, to determine safety and quality of white rice, brown rice, corn grits, other cereals, and various food and food products. Other activities included the testing of packaging materials and label evaluation; heat penetration and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.
