
National Food Authority Accomplishment Report May 2017

MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS

PROCUREMENT

a. Palay

For the month of May 2017, NFA procured 2,250 MT of palay, which is 14% accomplishment of the month's target of 15,760 MT. The slight increase in procurement based on target from 12% was due to continued government's intensified procurement activities in surplus provinces.



DISTRIBUTION

For the month of May, NFA distributed 58,033.45 MT of rice, equivalent to 58% accomplishment of the target of 99,955 MT.

PRICES

Based on the Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price posted an increase of P0.46 from last month's price of P18.83 to P19.29 for this month, NFA's buying price for palay is comparatively lower by P2.29/kg., compared to the prevailing commercial level, NFA's buying price for yellow corn, was higher by P0.77/kg., while for white corn, it is lower by P0.43/kg.

Both wholesale and Retail prices of WMR and RMR posted a slight increases of P0.24/kg. and P0.29/kg. in wholesale, and P0.25/kg. and P0.40/kg., in the retail, respectively. Yellow Corn also manifested an increase of P0.05/kg. in wholesale and P0.11/kg. in retail. White Corn posted a P1.68/kg., increase in wholesale, but showed decrease of P0.50/kg. in retail level.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of May 31, 2017, NFA had a stock inventory of 4,263,969 bags (total rice equivalent – TRE) or 213,198.5 MT, good to last for 7 days, based on the 2017 national daily rice consumption requirement of 32,720 MT.

The MAFF-JAPAN thru ASEAN PLUS THREE EMERGENCY RICE RESERVE (APTERR) TIER 3 Program, donated 4,500 bags or 225 MT of rice, currently stored at NFA-Visayas Warehouse.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS FOR THE MONTH OF MAY 2017

The total volume of assessed NFA stored grains as of the end of May 2017 was 4,566,688.3 bags, composed of palay, milled rice and corngrains, a decrease of 23.74% from the April 2017 volume of 5,988,362 bags. Stocks fit as food (rice) and feed (corn) represent 99.97% of the total assessed grains. Stocks for disposition were 1,459.6 bags (0.03%), composed of sweepings and partially damaged stocks, and 84.7 bags (0.002%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of May, NFA registered and licensed 3,472 applicants, 81 of whom availed of the three-year (2018-2020) advance-license scheme. Total R/L collections on grains business activities amounted to P8,953,035.83, which include collection from mobile licensing amounting to P1,644,082.89, and P57,275.02 from advance license collections. 421 metal plates were issued/sold for P84,200. The R/L fees comprised 79.80% of the annual targeted collection of P143M.

For the month of May, FDC performed 13 physical and sensory evaluation, 381 chemical analysis, 234 microbiological, and 4 micro analytical quality evaluation, to determine safety and quality of white rice, brown rice, corn grits, other cereals, and various food and food products. Other activities included the testing of packaging materials and label evaluation; heat penetration and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.
