
National Food Authority Accomplishment Report November 2017



MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of November 2017, NFA procured 6,589 MT of palay, which is 12.17% accomplishment of the month's target of 54,123 MT. The slight increase in procurement level compared to last month's 10.72% can be attributed to the harvest month and adequate supply of commercial rice in the market.



DISTRIBUTION

For the month of November, NFA distributed 56,281 MT of rice, equivalent to 72.59% accomplishment of the month's target of 77,535 MT.



PRICES

Based on the Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price posted an increase of P0.41 from last month's price of P18.70 to P18.51 for this month. NFA's buying price for palay is comparatively lower by P1.51/kg., compared to the prevailing commercial level. NFA's buying price for yellow corn, was higher by P0.23/kg., while for white corn, it is lower by P3.29/kg.

The wholesale prices of WMR and RMR posted slight increases of P0.05/kg. and P0.09/kg. respectively, but remained stable in the retail level. Yellow Corn manifested a slight increase of P0.22/kg. in wholesale and P0.05/kg. in the retail. White Corn also showed increases of P0.81/kg. and P0.19/kg. in wholesale and retail levels respectively.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED RICE STOCK INVENTORY

As of November 30, 2017, NFA stock inventory of 3,160,478 bags (total rice equivalent – TRE) or 158,023.9 MT, is good to last for 5 days, based on the 2017 national daily rice consumption requirement of 31,463 MT.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS FOR THE MONTH OF NOVEMBER 2017

The total volume of assessed NFA stored grains as of the end of November 2017 was 3,254,857.2 bags, composed of palay, milled rice and corngrains, a decrease of 15.91% from the October 2017 volume of 3,871,051.6 bags. Stocks fit as food (rice) and feed (corn) represent 99.97% of the total assessed grains. Stocks for disposition were 1,093.7 bags (0.034%), composed of 512.9 bags (0.016%) sweepings, 534.9 bags (0.016%) partially damaged stocks, and 45.9 bags (0.001%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of November, NFA registered and licensed 950 applicants, 3 of whom availed of the two-year (2018-2019) advance-license scheme. Total R/L collections on grains business activities amounted to P1,756,323.20, which include collection from mobile licensing amounting to P437,410.50, and P43,010 from advance license collections. 479 metal plates were issued/sold for P95,800.00. The R/L fees activities already accomplished P120.46% of the annual targeted collection of P143M.

Testing

For the month of November, FDC performed one physical and sensory evaluation, 155 chemical analysis, 98 microbiological, and six micro analytical (Filth) quality evaluation, to determine safety and quality of white rice, brown rice, corn grits, other cereals, and various food and food products. Other activities included the testing of packaging materials and label evaluation; heat penetration and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.
