Nestor A. Espenilla, Jr. joined the BSP in 1981 and steadily rose through the ranks, served as a Deputy Governor since 2005, and appointed as the BSP Governor and Chairman of the Monetary Board on 3 July 2017. He has accumulated more than 35 years of active operational engagement in all key facets of modern Philippine central banking (monetary policy, banking supervision and financial regulation, payments system oversight, capital markets development, currency management, consumer protection, and financial inclusion advocacy).

As the Deputy Governor in-charge of the Supervision and Examination Sector, he championed needed banking reforms by implementing good corporate governance practices, open competition, foreign bank entry liberalization, fair treatment of customers, and financial transparency.

He earned a BS degree in Business Economics and an MBA from the University of the Philippines, and an MS in policy science from the Graduate Institute of Policy Science (GRIPS) in Tokyo, Japan. He was seconded to the International Monetary Fund from 1990 to 1992.



DIWA C. GUINIGUNDO

Deputy Governor Monetary Stability Sector Bangko Sentral ng Pilipinas



Diwa C. Guinigundo rose from the ranks of the Bangko Sentral ng Pilipinas (BSP) and is now Deputy Governor for the Monetary Stability Sector, BSP. He has been serving the BSP for 39 years. He was assistant governor for monetary policy and international operations prior to his appointment as deputy governor in 2005.

In 2001-2003, he was Alternate Executive Director at the International Monetary Fund in Washington, DC. Earlier he was Head of Research at The SEACEN (Southeast Asian Central Banks) Centre in Kuala Lumpur in 1992-1994.

Since 2000, Deputy Governor Guinigundo has co-chaired with Bank Negara Malaysia the SEACEN Experts Group on Capital Flows and in 2010-2013, the ASEAN Senior Level Committee on Financial Integration and will serve as co-chair for the second time in 2016-2018. He also chairs the SEACEN Task Force on SEACEN membership.

For the period 2009-2012, he chaired the Executive Meeting of East Asia and the Pacific (EMEAP) Monetary and Financial Stability Committee of EMEAP central bank deputies that is tasked to conduct regional and global surveillance.

Deputy Governor Guinigundo graduated, cum laude, at the top of his AB Economics Class at the University of the Philippines (UP) School of Economics. He earned the M.Sc. degree in Economics at the London School of Economics (LSE) as a scholar of the Central Bank of the Philippines.



He was a shareholder, and board chairman or member of over a dozen corporations across various industries such as power, agriculture, mining, banking, hospitality, real estate, and investment.

Notable positions held by Sonny were Cabinet Secretary of the Environment and Natural Resources and Agriculture during the Presidency of Corazon Aquino, past president of leading Philippine corporations such as the Philippine Airlines and the Philippine Associate Smelting and Refining Corporation, and the former Bank of the Philippine Islands Agricultural Bank.

Ms. Rosalia V. De Leon is reappointed as Treasurer of the Philippines. She directs the formulation of policies on borrowing, investment and capital market development and handles the formulation of adequate operations guidelines for fiscal and financial policies.

Prior to her designation, Ms. De Leon served as the Alternate Executive Director (For the constituency of Brazil, Colombia, Dominican Republic, Ecuador, Haiti, Panama, Philippines, Suriname, and Trinidad and Tobago) at the World Bank Group, Washington D.C. USA. She also assumed key positions in the Department of Finance, including Undersecretary for International Finance Group from July 2007 to November 2012, Finance Secretary's Chief of Staff from July 2005 to June 2010 and Director for International Finance Group from September 1995 to August 1998. She served as Advisor to the Executive Director of the Asian Development Bank from August 1998 to August 2004. As the Undersecretary for the International Finance Group, she taskmanaged several landmark transactions including the issuance of Global Peso Notes as well as several Liability Management Exercises to reduce funding costs, extend maturity profiles and redenominate foreign exchange liabilities to local currency. In 2012, her team launched the Onshore Dollar Bonds to take advantage of foreign exchange liquidity in the domestic market. Ms. De Leon has represented the Department of Finance in many international fund mobilization activities for public sector entities and formulated borrowing strategies and appropriate credit enhancements to access least cost financing options. As the National Treasurer in 2013, Ms. De Leon also led the implementation of the Treasury Single Account as part of the Public Financial Management reforms initiated by the government. The TSA made it easier to manage the cash holdings of the National Government thereby improving the efficiency of Treasury operations.

Ms. De Leon earned her Master of Arts in Development Economics from Williams College Massachusetts.

Mr. Roberto B. Tan was re-appointed Treasurer of the Philippines in January 2015. From January 2015 to March 2016, Mr. Tan concurrently served as the Officer-in-Charge of the International Finance Group of the Department of Finance.

Mr. Tan was first appointed as Treasurer of the Philippines in July 2008 and became World Bank Executive Director in November 2012. Mr. Tan has an extensive experience in public finance having assumed several key positions in the Department of Finance, including Undersecretary from 2005 to 2008, Assistant Secretary from 1999 to 2005, and Director in the early 1990s for the International Finance Group. Mr. Tan also assumed the post of Advisor to the Executive Director of the Asian Development Bank Board. His professional background includes treasury management, international finance, consumer credit, and management consulting.

Mr. Tan holds a Master's degree in Economics from the Fordham University, New York, where he also pursued doctoral studies. He obtained his MBA from the Ateneo de Manila University where he likewise received his Bachelor's degree in Economics.

Executive Summary

As the National Treasurer, Mr. Tan directs the formulation of policies and execution of the strategy on borrowing, funds investment and bond market development. He leads the improvement and implementation of guidelines on Treasury operations. Mr. Tan oversees the maintenance of books of accounts of NG cash transactions, cash resources, and advances. He manages the control and servicing of NG public debt, both foreign and domestic, as well as the issuance and redemption of government securities and the administration of the Bond Sinking Fund and the Securities Stabilization Fund. He likewise oversees the custody of financial assets of Government and the bonding of all accountable public officials and employees. He heads the implementation of special laws that vest in the Bureau of the Treasury roles relating to fiscal and financial administration of the government.

Mr. Tan led several landmark international and local bond transactions for Financing and Liability Management which reduced funding costs, extended maturity profiles, deepened liquidity, and retired expensive/illiquid bonds. During his stint as Undersecretary/OIC of the International Finance Group, Mr. Tan headed the strategy formulation and funds mobilization activities involving multilateral and bilateral institutions. Dr. Pernia has close to 18 years experience at the Asian Development Bank (ADB), starting as Economist, rising to Senior Economist, Principal Economist, and then Lead Economist. He developed and directed projects in various Asian countries on investment climate and productivity, economic growth and poverty reduction, education and health, human resource development, and regional economic cooperation. He led staff and a dozen consultants that produced the seven-volume study on the "East ASEAN Growth Area: Brunei Darussalam, Indonesia, Malaysia. Philippines" (1996) — which provided the roadmap for the implementation of the landmark regional cooperation undertaking. He also represented ADB at various international development conferences in North and Latin America, Europe and Africa, besides Asia.

He has chaired the board of trustees of the University of San Carlos (2011-2014), having been a trustee since 2005; and was a director on the board of the Philippine-American Academy of Science and Engineering (2008-2013). Currently, he is on the board of Holy Name University (Tagbilaran). As well, he sits on the board of the Philippine-Russian Business Assembly, and previously on the board of the First Philec Solar Corporation. Further, he serves on the boards of a number of NGOs, including the Philippine Center for Population and Development, Forum for Family Planning and Development, Friendly Care Foundation, and *Bahay Tuluyan*, variously involved in promoting quality education and health, science and technology, poverty reduction, improved governance, and population and development.

Dr. Pernia had been Professor of Economics and Chairman, Department of Economics at the UP School of Economics, and previously Director for Research. He was granted the *Balik Scientist* award by the Department of Science and Technology (DOST). He is a former President of the Philippine Economic Society and Co-Chair of the Federation of ASEAN Economic Associations (1988).

He has written a number of books, numerous articles in international professional journals, and chapters of books. Dr. Pernia was chosen in February 2015 by the Philippine-American Academy of Science and Engineering (PAASE) for the Science Award. 
