
National Food Authority Accomplishment Report June 2018



MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of June 2018, NFA procured 226 MT of palay, which is 15% accomplishment of the month's target of 1,505 MT. The continued low procurement is still due to the prevailing high farm-gate prices of palay, at P21.31/kg., (as of June 30, 2018), P4.31/kg. higher than the government's buying price of P17.00/kg.



DISTRIBUTION

For the month of June, NFA distributed $8,168\,$ MT of rice, equivalent to 15.35% accomplishment of the month's target of $53,208\,$ MT. The slight increase in NFA's distribution of rice in the market, from last month's 5.84%, is due to import arrivals under Open Tender and G to G Scheme.

For June 2018, 133 farmers sold their palay to NFA, a slight increase compared to last year's record of 130 farmers. Total palay deliveries of 2,343.12 bags, amounting to P1.993M is 89% lower than last year's same period deliveries of 20,273.45 bags, amounting to P17M.

PRICES

Based on the Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price posted an increase of P0.29 from last month's price of P21.02 to P21.31 for this month. NFA's buying price for palay is comparatively lower by P4.31/kg., compared to the prevailing farmgate price level. NFA's buying prices for yellow and white corn were likewise, lower by P1.64/kg. and P3.16/kg. than the prevailing commercial prices, respectively.

Prices of WMR and RMR posted increases of P0.34/kg. and P0.30/kg. in the wholesale level, and P0.35/kg. and P0.40/kg. in the retail level, respectively. For yellow corn, wholesale price remains the same, but manifested an increase of P0.82/kg. in retail. For white corn, wholesale price increased by P0.77/kg.

MFO 3: BUFFER STOCK OF STAPLE CEREALS

RICE STOCK INVENTORY

As of June 30, 2018, NFA stock inventory of 1,097,086 bags (total rice equivalent –TRE) or 54,854.3 MT, is good to last for 1.71 days, based on the 2018 national daily rice consumption requirement of 32,013 MT.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS

The total volume of assessed NFA stored grains as of the end of June 2018 was 1,066,429.50 bags, an increase of 1,851% from last month's volume of 54,643.1 bags. Stocks fit as food (rice) and feed (corn) represent 99.98% of the total assessed grains. Stocks for disposition totaled 166 bags, composed of 17 bags (0.002%) of partially damaged stocks and 149 bags (0.014%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of June, NFA registered and licensed 5,152 applicants, Total R/L collections on grains business activities amounted to P23,597,843.85 including mobile licensing amounting to P476,502.45. No metal plates were issued this month. The cumulative R/L fees collected amounting to P140,187,706.49 represents 93.46% of the annual target collection of P150M. Note that majority of those who applied for licenses are engaged in the selling of commercial rice.

Import License – issued by Industry Services Department under PD4 to Grains Businessmen involved in different lines of activities involving grains in a specified quantity, during a specified period (usually one year).

Import Permit – Issued by NFA to Grains Importers on a per shipment basis, required by BOC for the release of the cargo (grains).

FOOD DEVELOPMENT CENTER

For the month of June, FDC performed 2 physical and sensory evaluation, 71 chemical analysis, one microanalytical (Filth), and 37 microbiological quality evaluation, to determine safety and quality of white rice, brown rice, corn grits, other cereals, and various food and food products. Other activities included the testing of packaging materials and label evaluation; heat penetration and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.
