




I. SUPPLY AND PRICE OF STAPLE CEREALS

PROCUREMENT

Palay

For the 3rd quarter of 2018, NFA procured 451 MT of palay, which is 2.82% accomplishment of the quarter's target of 15,998 MT. This is 7.65% lower than the 10.47% accomplishment for same quarter last year. The consistent low procurement for this quarter is due to higher prevailing average farm-gate price of palay at ₱23.30/kg, as of September 30, 2018, ₱6.30 higher compared with the government buying price of ₱17.00/kg, plus ₱0.70/kg incentive.




IMPORTATION

The remaining 78,600 MT out of the 250,000 MT total importation under G-to-G agreement, were already delivered during the 3rd quarter of 2018. Of these, 65,600 MT were completed discharged, while 13,000 MT were still at the disports as of September 26, 2018. On the other hand, rice importation under the Open-Tender Scheme started coming in July 2018, when 72.26% (180,641 MT) of the 250,000 MT total importation already arrived, while the remaining 27.74% (69,359 MT) is scheduled to arrive in October.

DISTRIBUTION

For the 3rd quarter of 2018, NFA distributed 240,974 MT of rice, equivalent to 112% accomplishment of the quarter's target of 215,156 MT. There is an 81.55% increase in distribution compared to 30.45% of last year's 3rd quarter distribution. The increase in distribution is part of NFA's counter-inflationary measure, by increasing its market participation to up to 13.56% by the end of September 2018.

The average ex-farm prices of palay for the quarter at ₱22.30/kg posted a₱ 4.60/kg increase from the NFA's buying price of₱17.7 0/kg. Likewise, ex-farm prices for yellow corn at ₱14.45/kg and white corn at ₱15.01/kg were higher by ₱2.15/kg and ₱2.01/kg respectively, compared to the NFA buying price.

For the 3rd quarter of 2018, WMR and RMR wholesale prices posted an average price of P43.99/kg and P40.86/kg, respectively. Both showed increases of 4.80/kg and P5.40/kg compared to the average prices in the 3rd quarter of 2017, respectively. On the retail level, WMR and RMR average prices were at 46.81/kg and P43.33/kg, with increases of P4.70/kg and P5.38/kg compared to 2017, respectively. Likewise, yellow corn wholesale and retail prices in the 3rd quarter of 2018 manifested increases of P2.49/kg and P2.93/kg, respectively, from 2017. White corn showed an increase of P3.52/kg in the average wholesale price, while a slight decrease of P1.20/kg in the retail level was noted, compared to the average prices in the 3rd quarter of 2017.

For the 3rd quarter of 2018, there were 97 farmers who sold palay to NFA. The total palay deliveries of 2,605 bags amounted to ₱2.24M.

II. BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

For the 3rd quarter of 2018, NFA had an average stock inventory of 2,204,953 bags (total rice equivalent –TRE) or 110,248 MT, good to last for 3.44 days, based on the 2018 national daily rice consumption requirement of 32,013 MT.

The total average volume of NFA stored grains assessed for the 3rd quarter of 2018 is 2,163,701.40 bags, composed of palay, milled rice and corn grits. Stocks fit as food (rice) represent 96.056% of the total assessed grains. Stocks for disposition were 46.57 bags (0.002%), composed of sweepings, partially damaged, and totally damaged stocks. The average volume of assessed NFA stocks as good was 2,078,364.63 bags.

For the 3rd quarter of 2018, the NFA registered and licensed 16,412 applicants, 262% higher than the 4,539 applicants for the same period in 2017; 232 applicants availed of the advance license scheme. Total R/L collections on grains business activities amounted to ₱11,692,170.43, which includes collection from mobile licensing amounting to ₱745,826.05, and ₱353,698.50 from advance license collections. There were 1,213 metal plates issued/sold for ₱511,400.00. For the quarter, the R/L fees posted an accomplishment of 7.79% of the annual target collection of ₱150M.

For the 3rd quarter of 2018, 43 UGNAYANs were conducted, participated in by 1,480 NFA stakeholders, 74% less than the 164 participants in 4,408 UGNAYAN sessions during the 3rd quarter of 2017. To check whether the PGSP Rules and Regulations are strictly observed, 18,473 grains business establishments were inspected for the 3rd quarter of 2018, a 370% increase from the 3,933 grains business establishments inspected in the 3rd quarter of 2017. NFA conducted 19,428 trainings and seminars to advocate PGSP rules and regulations, participated in by 14,247 NFA Stakeholders.

For the 3rd quarter of 2018, NFA issued/renewed licenses to 127 importers: 64 for farmer organizations and 63 for grains businessmen. Compared to the 3rd quarter of 2017, there was a 357% increase in licensed importers among farmer organizations, and a 117% increase from grains businessmen.

The NFA Kontra Abuso Hotline was launched last July 10, 2018, to monitor and stop illegal activities concerning NFA rice. During the 3rd quarter of 2018, the task force received 606 reports from the public and grains businessmen, 514 of which are text messages. Majority of complaints are about availability of NFA rice. 598 of the complaints have already been resolved, while there were seven which are still subject for investigation by Security Services and Investigation Department (SSID), the department in-charge during the first week of the launching of the NFA Kontra Abuso.
