

National Food Authority Accomplishment Report January 2019



MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of January 2019, NFA procured 7,658 MT of palay, which is 76.39% accomplishment of the month's target of 10,025 MT. The increase in procurement can be attributed to the additional \$\mathbb{P}\$3.00 incentive given by NFA as Buffer Stocking Incentive (BSI).



DISTRIBUTION

For the month of January, NFA distributed 78,935 MT of rice, equivalent to 79.83% accomplishment of the month's target of 98,885 MT.



PRICES

Based on the Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price posted a decrease of P0.25 from last month's price of P20.08 to P19.38 for this month. NFA's buying price for palay is comparatively lower by P2.38/kg., compared to the prevailing farmgate price level. NFA's buying prices for yellow, and white corn were lower by P1.63/kg., P1.03/kg., respectively.

NFA started to buy palay at \$\text{P20.70/kg}\$. with the approval of Buffer Stocking Incentive (BSI) on October 12, 2018, consists of basic buying price of palay at \$\text{P17.00/kg}\$ with additional incentives of \$\text{P0.30}\$ for CDIF, \$\text{P0.20}\$ for delivery fee, \$\text{P0.20}\$ for drying fee and \$\text{P3.00}\$ for Buffer Stocking.

Both wholesale and retail prices of WMR and RMR posted decreases of P0.38/kg. and P0.47/kg. in the wholesale level, and P0.31/kg. and P0.42/kg. in retail level, respectively. For yellow corn, wholesale and retail prices, manifested decreases of P0.19/kg. and P0.60/kg. but showed a slight increase of P0.02/kg. in wholesale and a decrease of P0.70/kg. in retail level.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of January 31, 2019, NFA stock inventory of 5,952,327 bags (total rice equivalent –TRE) or 297,616 MT, is good to last for 9.13 days, based on the 2018 national daily rice consumption requirement of 32,013 MT, while based on the Average Daily Sales (ADS) of 3,350 MT, at a market participation of 10.28%, NFA stocks is expected to last for 88.85 days.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS

The total volume of assessed NFA stored grains as of the end of January 2019 was 6,262,814 bags, composed of palay, milled rice and corngrains, an increase of 164% from the December 2018 volume of 2,363,556 bags. Stocks fit as food (rice) and feed (corn) represent 99.997% of the total assessed grains. Stocks for disposition were 228.50 bags (0.003%) composed of 76.90 bags (0.001%) partially damaged stocks, and 151.60 bags (0.002%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of January, NFA registered and licensed 14,262 applicants, 586 of whom availed of the three-year (2020-2022) advance-license scheme. Total R/L collections on grains business activities amounted to \$\text{P36,969,632.24}\$, which include collection from mobile licensing at \$\text{P2,657,555.12}\$, and \$\text{P593,170.60}\$ from advance license collections. 1,290 metal plates were issued/sold for \$\text{P258,000}\$. The R/L fees collected is at 24.32% of the annual targeted collection of \$\text{P152M}\$.
