


# I. SUPPLY AND PRICE OF STAPLE CEREALS

#### PROCUREMENT


# Palay

For the 3<sup>rd</sup> quarter of 2020, NFA procured 126,936.60 MT of palay, which is 99.81% accomplishment of the quarter's 127,180 MT target. This is 37.89% higher than the 61.92% accomplishment (equivalent to 70,667 MT) for the same quarter last year. The high procurement can be attributed to the average ex-farmgate price of palay at P17.92 /kg being lower the NFA's buying price of P19.00/kg.



#### **DISTRIBUTION**

For the 3rd quarter of 2020, NFA distributed 58,690 MT of rice, equivalent to 98% accomplishment of the quarter's target of 58,857 MT. This is 9.49% lower than the 107.49% accomplishment (equivalent to 156,486 MT) for the same quarter last year. The high distribution can be attributed to the massive rice releases to DSWD, LGUs and other relief institutions, intended for COVID-19 relief operations.

The average ex-farm price of palay for the quarter was lower by ₱1.08/kg from the NFA's buying price of ₱19.00/kg. On the other hand, the ex-farm prices for yellow corn at ₱12.53/kg and white corn at ₱13.90/kg were higher by ₱0.23/kg and ₱0.90/kg respectively, compared to the NFA buying prices for corn.

For the 3rd quarter of 2020, WMR and RMR wholesale prices posted an average price of ₱38.80/kg and ₱42.35/kg, respectively. Compared with same period last year, both posted a slight average decrease of ₱0.02/kg and ₱0.14/kg. respectively. On the retail level, WMR and RMR average prices of ₱34.21/kg and ₱38.09/kg, posted an average decrease of ₱0.59/kg and ₱0.03/kg, compared to the same period in 2019, respectively.

Compared to 3rd quarter last year, wholesale prices of yellow corn registered an increase of ₱1.45/kg and retail prices decrease by ₱7.70./kg. On the other hand, wholesale and retail of white corn posted increases of ₱7.23/kg. and ₱0.61/kg., respectively.

#### II. BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

#### RICE STOCK INVENTORY

For the 3<sup>rd</sup> quarter of 2020, NFA's stock inventory of 4,950,368 bags (total rice equivalent –TRE) or 247,518.40 MT is good to last for 7.48 days, based on the daily rice consumption rate of 33,097 MT. However, based on Average Daily Sales of 14,330 bags, the inventory is good to last for 345.46 days. It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.

The total average volume of assessed NFA stored grains for the 3rd quarter of 2020 was 5,278,512.60 bags, composed of palay, milled rice and corn grains. Stocks fit as food (rice) and feed (corn) represent 99.983% of the total assessed grains. Totally damaged milled rice stocks for disposition consisted of 565.7 bags, equivalent to 0.011% of the total stock inventory.

#### HUMAN RESOURCE MANAGEMENT

When the government implemented the community quarantine, NFA assigned skeleton workforce to ensure continuity of NFA services to the public. As of September 30, 2020, most regions and provinces including National Capital Region (NCR) have been classified as General Community Quarantine areas, while others have been declared as Modified General Community Quarantine areas. Work arrangements have been set at 50% workforce reporting to office, while 50% are on work-from-home (WFH) work arrangement scheduled to shift weekly- to comply with the physical distancing protocol. Under the straight WFH arrangement are the most vulnerable members of the workforce. These are senior citizens, pregnant, and those with health issues.
