

• SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of October NFA procured 253,000 MT of palay, which is 126% accomplishment of the month's target of 201,570 MT. The high accomplishment can be attributed to the onset of procurement season and the high buying price of NFA compared with the prevailing ex-farm prices.



DISTRIBUTION

For the month of October, NFA distributed 20,542 MT of rice, equivalent to 109% accomplishment of the month's target of 18,890 MT.



PRICES

Based on the Philippine Statistics Authority (PSA) summary of ex-farm prices of palay and corn, palay ex-farm price of P 15.51/kg is lower by P 3.49/kg compared with the NFA's buying price of P19.00/kg. However, compared to last month's price of P16.96, NFA's buying price is lower by P1.45kg. NFA's buying prices for yellow and white corn are higher than the market level by P0.47/kg and P0.10/kg, respectively.

The wholesale and retail prices of well-milled rice (WMR) and regular-milled rice (RMR) generally decreased compared to last month's level at P0.78/kg and P0.64/kg, and P1.18/kg and P1.04/kg, respectively. Likewise, the wholesale and retail prices of yellow and white corn grains decreased by P0.48/kg and P0.35kg, and P0.04/kg and P2.87/kg, respectively.

RICE STOCK INVENTORY

As of October 31, 2020, NFA's stock inventory of 7,840,853 bags (total rice equivalent –TRE) or 392,042.65 MT is good to last for 11.85 days, based on the daily rice consumption rate. However, based on Average Daily Sales of 14,330 bags, the inventory is good to last for 387.80 days. It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.

By directly undertaking the troubleshooting, repair, verification and adjustment of metrology equipment service of its field offices, the agency saved an estimated amount of P67,250.00

Truckscale Utilization

NFA generated an income amounting to P7,420,016.53, from keeping the truckscales in good operating condition, and helping save on handling cost.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS

The total volume of assessed NFA stored grains as of October 31, 2020 was 9,365,166.20 bags, composed of palay, milled rice and corn grains. This is higher by 49.63% from September volume of 6,259,078.6 bags. Stocks fit as food (rice) and feed (corn) represent 99.996% of the total assessed grains. Milled rice stocks for disposition consisted of sweepings and totally damaged milled rice at 371.8 bags, equivalent to 0.004% of the total stocks.

HUMAN RESOURCE MANAGEMENT

When the government implemented the community quarantine, NFA assigned skeleton workforce to ensure continuity of NFA services to the public. As of October 31, 2020, most regions and provinces including National Capital Region (NCR) have been classified as General Community Quarantine areas, while others have been declared as Modified General Community Quarantine areas. Work arrangements have been set at 50% workforce reporting to office, while 50% are on work-from-home (WFH) arrangement scheduled to shift weekly, to comply with the physical distancing protocol. Under the straight WFH arrangement are the most vulnerable members of the workforce. These are senior citizens with comorbidity problems, pregnant, and those with health issues.
