
May 2020 Accomplishment Report



I. SUPPLY AND PRICE OF STAPLE CEREALS


PROCUREMENT

For the month of May, NFA procured 2,268 MT of palay, which is 2.74% accomplishment of the month's target of 82,810 MT. The low procurement can be attributed to the Covid crisis which limits the movement and activity of people to accessing essential good and services, and increased farm gate prices of palay at P19.05, slighly higher with the NFA buying price of P19.00/kg.



DISTRIBUTION

For the month of May, NFA distributed 58,828 MT of rice, equivalent to 156% accomplishment of the month's target of 37,674 MT. The high distribution is attributed to the massive rice releases to DSWD, LGUs and other relief institutions, intended for COVID-19 relief operations.



PRICES

Based on the Philippine Statistics Authority (PSA) summary of ex-farm prices of palay/rice, the average ex-farm price posted an increase of P0.78/kg from last month's price of P18.27/kg to P 19.05/kg for this month. NFA's buying prices for corn are still higher than the market level, at P0.44/kg for yellow corn grains (YGN) and P1.22/kg for white corn grains (WGN).

Wholesale prices of well milled rice (WMR) and regular milled rice (RMR) compared to last month's level, slightly increased by P0.42/kg and P0.20/kg respectively. On the other hand, retail prices of well-milled rice and regular-milled rice decreased by P0.05/kg and P0.74/kg, respectively. For yellow corn, wholesale and retail prices increased by P2.08/kg and P1.33/kg, while prices of white corn grain decreased by P2.08/kg. and P0.40/kg, respectively.

II. BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of May 31, 2020, NFA's stock inventory of 4,996,227 bags (total rice equivalent –TRE) or 249,811 MT is good to last for 7.55 days, based on the daily rice consumption rate. However, based on Average Daily Sales of 54,738 MT and is good to last for 91.28 days. It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.

Engineering Services

The construction of the following facilities are aimed to improve NFA's operations:

Metrology Services

During the month, NFA undertook troubleshooting, repair, verification and adjustment of metrology equipment of its Field Offices as requested. The agency saved an estimated amount of P73,000.00 for directly undertaking the troubleshooting, repair, verification and adjustment of metrology equipment service.

Truckscale Utilization

NFA generated an income amounting to \$\text{P5},203,609.37\$ from keeping the truck scales in good operating condition, and helping save on handling cost.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS

The total volume of assessed NFA stored grains as of May 31, 2020 was 6,945,342.60 bags composed of palay, milled rice and corn grains, a decrease of 36.96% from April volume of 11,016,910.7 bags. Stocks fit as food (rice) and feed (corn) represent 99.995% of the total assessed grains. Milled rice stocks for disposition were 344.7 bags, composed of (0.005%) totally damaged milled rice.

HUMAN RESOURCE MANAGEMENT

When the government implemented the community quarantine, NFA assigned skeleton workforce to ensure continuity of NFA services to the public. For May 1 to 31, 2020, a total of 1,842 personnel comprised the skeleton workforce. 226 (12.3%) from Central Office and 1,616 (87.7%) from all regions. As of May 31, 2020 some provinces were placed under General Community Quarantine status prompting most Field Offices to return to normal work schedules. Meanwhile senior citizens, pregnant, and those with health risks remain to be on a Work-From-Home (WFH) alternative arrangement.
