# ENSURE FOOD SECURITY THROUGH MAINTENANCE OF BUFFER STOCKS


### PALAY PROCUREMENT

For the 3rd quarter of 2021, NFA procured 71,960 MT of palay, which is 39.98% accomplishment of the quarter's target of 180,005 MT. This is about 55.74 % lower than the 129,089 MT accomplishment for the same quarter last year. The decrease in procurement can be attributed to the onset of lean months, plus the Enhance Community Quarantine lockdowns imposed by the National Government due to Covid-19 during the same period last year.

# **DISTRIBUTION**

For the 3rd quarter of 2021, NFA distributed 88,502 MT of rice, equivalent to 79.23% accomplishment of the quarter's target of 111,705 MT. This is 66.54% higher than the 58,888 MT accomplishment for the same quarter last year. The higher distribution can be attributed to continued rice distribution from DSWD to LGUs and other relief institutions, intended for COVID-19. relief operations


NFA Rice Distribution

# **NFA INVENTORY**

As of September 30, 2021, NFA's stock inventory of 3,148,455 bags (total rice equivalent –TRE) or 157,422.75 MT is good to last for 4.69 days, based on the daily rice consumption rate (DCR) of 671,280 bags or 33,564 metric tons. However, based on Average Daily Sales of 27,362 bags, the inventory is good to last for 115.07 days, It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.

For the 3rd quarter of CY 2021, based on the new rating scale approved by the GCG, The computed average rating of 99.997% is within the agency's target commitment, as presented below.
