

#### PALAY PROCUREMENT


For the month of July, NFA procured 4,518.3 MT of palay, which is 30.12% accomplishment of the month's target of 15,000 MT. The low accomplishment level is due to the lean month season.

# **DISTRIBUTION**

For the month, NFA distributed 29,820.05 MT of rice, equivalent to 88.59% accomplishment of the month's target of 33,660 MT. The slight increase in distribution can be attributed to high rice releases to DSWD and LGUs intended for COVID-19 relief operations.

# **NFA INVENTORY**

As of July 31, 2021, NFA's stock inventory of 3,553,106 bags (total rice equivalent –TRE) or 177,655.30 MT is good to last for 5.29 days, based on the daily rice consumption rate (DCR) of 671,280 bags or 33,564 metric tons. However, based on Average Daily Sales of 30,318 bags, the inventory is good to last for 117.20 days, with a market participation rate of 4.52%. It should be noted that NFA's inventory is only part of the national rice inventory of the entire country.

#### **HUMAN RESOURCE MANAGEMENT**

Upon the order of President Rodrigo Duterte to put the NCR+ plus bubble (Metro Manila, Bulacan, Cavite, Laguna and Rizal) under General Community Quarantine (GCQ) from July 1 to 31, 2021, the NFA adhered to the instruction to operate under a minimum of 30% to a maximum of 50% operational capacity, to ensure continuity in the delivery of our services to the public.
