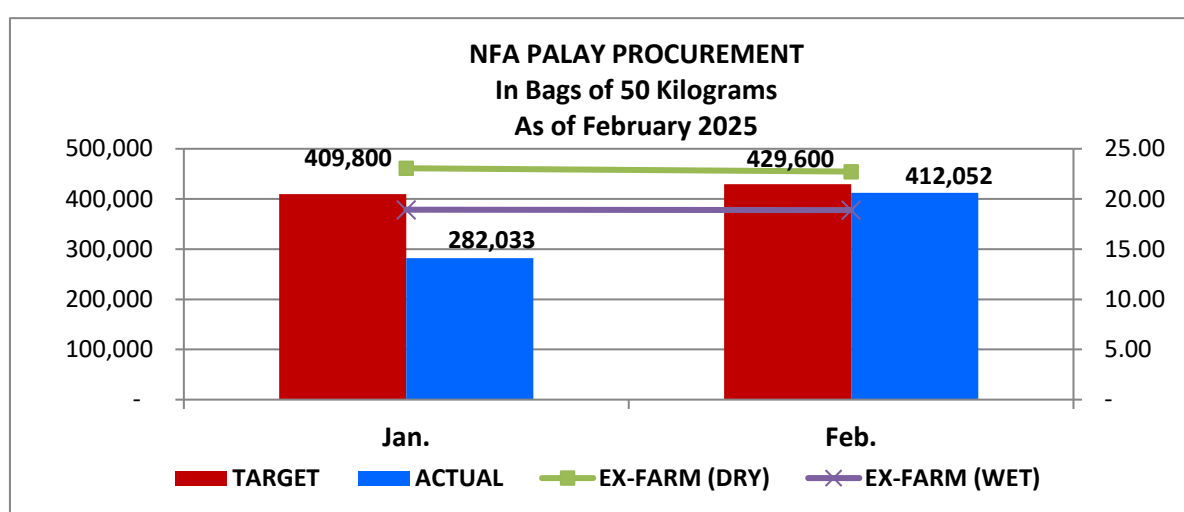


I. OPERATIONS COORDINATION DEPARTMENT

A. Ensure Food Security through Maintenance of Adequate Buffer Stock Sourced from Local Farmers

1. Palay Procurement

For the month of February the National Food Authority (NFA) procured 412,052 bags (20,602.6 MT) of palay, reaching 95.92% of its target of 429,600 bags (21,480 MT). Increase in procurement compared to last month is mainly due to the on-set of harvest season, and the implementation of the Council-approved Price Range Scheme (PRICERS) for palay procurement activity.

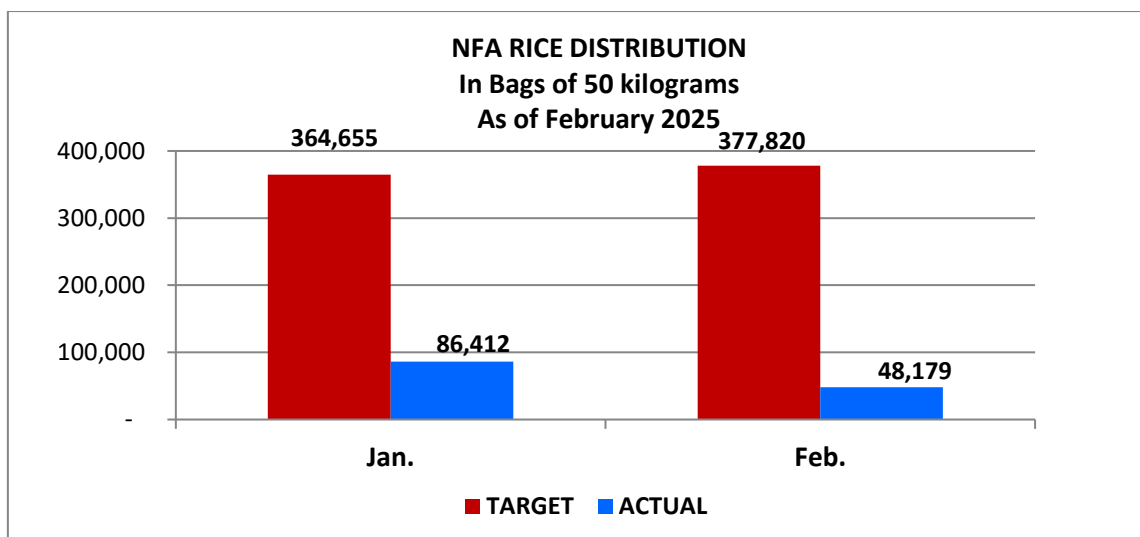


Note: Monthly Procurement volume subject to adjustment and updating

2. Distribution

For the month of February, NFA distributed 48,179 bags (2,409 MT) of milled rice, achieving only 12.75% of the target of 377,820 bags (18,891 MT), despite the declaration of Food Security Emergency (FSE) issuance were made to the following:

- 23,592 bags to DSWD, OCD, Legislators, and LGU's for relief operations / calamity response
- 14,795 bags for government agencies and LGU's rice requirement under EO-51 program
- 7,792 bags for the grant of One-Time Rice Allowance
- 2,100 bags for LGU's under the Food Security Emergency ProgramV



3. NFA Inventory

As of February 28, 2025, NFA has a Total Expected Milled Rice Inventory (TEMRI) stock inventory of 6,000,462 bags (300,023 MT). It should be noted that NFA's inventory is 14% of the country's national rice inventory.
