
April 2025 Accomplishment Report



I. OPERATIONS COORDINATION DEPARTMENT

A. Ensure Food Security through Maintenance of Adequate Buffer Stock Sourced from Local Farmers

1. Palay Procurement




For the month of April the National Food Authority (NFA) procured 1,807,810 bags (90,390.5 MT) of palay, reaching 157.37% of its target of 1,148,800 bags (57,440 MT). Increase in procurement compared to last month is mainly due to favorable harvest this cropping season, and the continuous implementation of the Council-approved Price Range Scheme (PRICERS) for palay procurement activity.

2. Distribution

For the month of April, NFA distributed 84,737 bags (4,236.85 MT) of milled rice, achieving only 18.91% of the target of 448,150 bags (22,407.5 MT), despite the declaration of Food Security Emergency (FSE). Issuances were made to the following:

- 51, 641 bags to DSWD, OCD, Legislators, and LGU's for relief operations / calamity response
- 17,496 bags for government agencies and LGU's rice requirement under EO-51 program
- 8,369 bags for the grant of One-Time Rice Allowance
- 7,231 bags for LGU's under the Food Security Emergency Program



3. NFA Inventory

As of April 30, 2025, NFA has a Total Expected Milled Rice Inventory (TEMRI) stock inventory of 7,944,118 bags (397,206 MT). It should be noted that NFA's inventory is 14.8% of the country's national rice inventory.
