


MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS

PROCUREMENT

a. Palay

For the month of May 2016, NFA procured 5,002 MT of palay, which is 38% accomplishment of the monthly target of 13,140 MT. Procurement for this month decreased drastically compared to 92% accomplishment last month due to the early onset of lean months and the impact of "El Niño"/ drought in selected rice production areas nationwide.



DISTRIBUTION

NFA distributed 98,125 MT of rice, equivalent to 95.48% accomplishment of the target of 102,770 MT for the month of May.

IMPORTATION

Of the 750,000 MT rice contracted in preparation for "El-Niño", 733,221 MT or 97.76% have been delivered to NFA warehouses.

PRICES

Based on Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price for palay posted an increase of P0.27/kg or from P17.96/kg last month to P18.23 this month.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of May 31, 2016, NFA had a stock inventory of 21,433,551 bags (total rice equivalent – TRE) or 1,071,677 MT, good to last for 33 days, based on the 32,150 MT national daily rice consumption requirement.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS FOR THE MONTH OF MAY 2016

The total volume of assessed NFA stored grains for the month is 23,068,386.4 bags, mostly well-milled rice. Stocks fit as food (rice) represents 99.97% of the total assessed grains. Stocks for treatment were 587,533 bags (2.55% of the total assessed grains). Stocks for disposition were 4,147.5 bags (0.018%) composed of sweepings, partially damaged stocks and 3,361 bags (0.015%) of totally damaged milled rice due to typhoon "Nona".

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of May, NFA registered and licensed 8,950 applicants, of which 376 grains businessmen availed of the two-year (2017-2018) advance-license scheme. Total R/L collections on grains business activities amounted to P15,222,820.40, which includes collection from mobile licensing amounting to P2,580,854.99, and P696,255.36 from advanced collections. 1,197 metal plates were issued/sold for P239,400. The cumulative R/L fees comprised 72.36% of the annual targeted collection of P154M.
