


MFO 1: STABLE SUPPLY AND PRICE OF STAPLE CEREALS

PROCUREMENT

a. Palay

For the month of October 2016, NFA procured 17,065 MT of palay, which is 34.41% accomplishment of the month's target of 49,598 MT. The increase in procurement is due to the onset of the harvest season.



DISTRIBUTION

For the month, NFA distributed 73,954 MT of rice, equivalent to 71% accomplishment of the target of 104,200 MT for October.

IMPORTATION

Of the 250,000 MT imported for the lean months, 93,977 MT or 37.6% have been delivered to NFA warehouses.

PRICES

Based on Philippine Statistics Authority (PSA) summary of commercial palay/rice prices, the average ex-farm price declined further by 5.75% to £17.55/kg from £18.62/kg in September.

Rice prices continue to post a decrease from last month's prices. Wholesale and retail prices of WMR decreased by P0.50/kg and P0.26/kg, respectively. Likewise for RMR, there was a P0.38/kg decrease in wholesale, and P0.18/kg in retail prices.

MFO 3: BUFFER STOCK OF STAPLE CEREALS EFFECTIVELY MANAGED

RICE STOCK INVENTORY

As of October 31, 2016, NFA had a stock inventory of 10,923,226 bags (total rice equivalent –TRE) or 546,161.3MT, good to last for 17 days, based on the 2016 national daily rice consumption requirement of 32,150 MT.

NATIONAL QUALITY ASSESSMENT (QSAR) OF NFA STOCKS FOR THE MONTH OF OCTOBER 2016

The total volume of NFA stored grains assessed for the month of October is 11,725,538.4 bags, composed of palay, milled rice and corngrits, an increase of 6.9% from the September volume of 10,968,323 bags. Stocks fit as food (rice) represents 99.953% of the total assessed grains. Stocks for disposition were 4,387 bags (0.038%) composed of sweepings, partially damaged stocks and 1,067.9 bags (0.01%) of totally damaged milled rice.

MFO 4: DEVELOPMENTAL REGULATION OF THE GRAINS INDUSTRY IMPLEMENTED AND ENFORCED

REGISTERED/LICENSED GRAINS BUSINESSMEN

For the month of October, NFA registered and licensed 1,912 applicants, of which 73 grains businessmen availed of the two-year (2017-2018) advance-license scheme. Total R/L collections on grains business activities amounted to \(\text{P3},475,113.42, \) which includes collection from mobile licensing amounting to \(\text{P1},175,228.99, \) and \(\text{P42},350.00 \) from advanced collections. 850 metal plates were issued/sold for \(\text{P170},000.00 \) The cumulative R/L fees comprised 97.06% of the annual targeted collection of \(\text{P154M}. \)

<u>Testing</u>

For the month, FDC performed 34 chemical analysis, and 35 microbiological quality evaluation, to determine safety and quality of white rice, brown rice, corn grits, other cereals, and various food and food products. Other activities included the testing of packaging materials and label evaluation; heat penetration and heat distribution test to establish and/or evaluate adequacy of thermal processes of canned goods; shelf life testing to establish shelf life of various packaged products; and the conduct of seminar/training.
