Screening of qualified bidders will be conducted prior to pre-bidding conference as stated on the schedule of activities above, only the bidders who will be found complying upon screening are allowed to attend the pre-bidding conference.

Failure to attend of the qualified bidders on the pre-bidding conference will mean automatic ineligibility to participate in the bidding proper.

Bids must be accompanied by Bid Bond based on the ranges of total amount of bid price stated on the attached Conditions of Sale in the form of cash, cashier's check or manager's check payable to NFA issued by a reputable commercial bank.

The conditions of Sales and Tender Forms can be secured from NFA Capiz Branch Office or it may be downloaded free-of-charge from the NFA Website provided that the Bidders shall pay the applicable fee of Five Hundred Pesos (Php 500.00) for the bidding documents/Tender Forms until November 27, 2024, 8:00AM-5:00PM in order to participate in the bidding.

5. BID BOND

Bidder's bond equivalent to ten percent (10%) of the total amount of the offer in the form of cash, manager's or cashier's check in favor of NFA shall accompany the sealed bid. Otherwise, the bid shall be automatically rejected. The bidder's bond shall be converted into a performance bond.

A temporary Receipt (TR) shall be given to the bidder by the NFA upon receipt of his/her/their bond. Bid bonds of non-winning bidders shall be returned on the day of bidding upon submission of corresponding acknowledge receipts.

SCHEDULE OF PRE- BID CONFERENCE AND BIDDING PROPER

Bidders which have no complete eligibility documents during screening will be automatically disqualified and not allowed to attend the Pre-bid Conference which shall be conducted on November 28, 2024 at 10:00A.M. at NFA Capiz Branch Office, Bolo. Roxas City, Capiz.

The opening of Tender Forms/Bids of eligible bidders shall take place immediately after the deadline for the submission of eligibility/ documentary requirements and Bids/Tender forms at 1:30 P.M. on November 28, 2024 to be held at NFA Capiz Branch Office, Bolo, Roxas City, Capiz. At which time and place, the Branch Office's Disposition Committee shall open the tender forms/bids publicly in the presence of the bidders or their authorized representatives and other parties.

7. TENDER FORMS/ BIDS

The quoted price must be on per kilogram basis and up to two (2) decimal places only. Bids lower than the Minimum Bid Price (MBP) shall automatically be rejected at the bid opening.

8. AWARDING

The winning bidder shall be the one with the highest bid or above the minimum bid price. In case of two or more bidders have equal acceptable bid/ offer for the whole lot, a tie must be resolved thru a "draw lots", "toss coin" or other similar methods of chance.

The winner shall be given the Notice of Award as approved by the Regional Manager.

9. PERFORMANCE BOND

The winner shall post a performance bond equivalent to ten percent (10%) of the total amount of the bidding in the form of cash, cashier's / manager's check payable to NFA. The bid bond shall automatically be converted to Performance Bond which form part of the payment to be applied on the last payment of the awarded empty sacks upon determination that the winning bidders has no outstanding obligation with NFA.

10. PAYMENT SCHEME

Full payment for the whole lot, as bidden shall be made within forty-eight (48) hours from the receipt of Notice of Award (NOA) either in Cash, Manager's or Cashier's Check.

The computation for payment of by-products (DKA) withdrawn shall be based on net weight.

Failure of the winning bidder to pay the awarded volume of by-products DKA within the prescribed period, shall mean forfeiture of the performance bond in favor of NFA or at NFA's option without the necessity of court action. In which case, the Bidding Committee shall reconvene and decide when to conduct a rebidding.

That inasmuch as the weight of the by-products(DKA) subjected to bidding are merely based on estimates which are the bases of the payment prior to the issuance of the "Authority to Issue" there are instances that the estimated weight exceeds that which had been actually paid by the awardee in which case, the awardee shall be under obligation to make additional payments corresponding to the excess and to withdraw the same within the original period.

Likewise, if by-products (DKA) withdrawal is less than what the buyer has paid for, the NFA shall reimburse the balance following the NFA reimbursement voucher system.

11. WITHDRAWAL PERIOD

Only paid awarded by-products (DKA) shall be allowed/ authorized for withdrawal. The paid awarded volume of winning bidder shall be withdrawn within the allowable withdrawal period of fifteen (15) days reckoned from the issuance of Authority to Issue (AI). Otherwise, a storage fee of P 0.50 per bag per day shall be charged by the NFA to whatever balance thereof not withdrawn within the period shall be borne by the winning bidder.

12. VALIDITY OF BID

The bid shall be valid up to twenty (20) working days from submission of bid.

13. OTHERS

The National Food Authority reserves the right to reject any or all bids, to waive any formality thereof, and to accept only such bids that are advantageous to the Agency.
