Other Provisions:

1. The P18.25/kg consumer price shall be implemented for rice sales to holders/beneficiaries of DSWD-issued Family Access Cards (FAC) in Metro Manila and the Rice Allocation Ledgers (RAL) in the field offices. Otherwise, the P25.00/kg consumer selling price shall apply in the sales transactions to non-holders of FAC/RAL.

2. For rice purchases delivered, the delivery fees to be charged against the buyers shall follow the provisions of wire coded AO-2K8-D-002 dated March 31, 2008, to wit:

Within 10-kilometer radius	-	P15.00/bag of 50 kg
Above 10-35 kilometers	-	P25.00/bag of 50 kg
Beyond 35 kilometers	-	Prevailing rate in the area but not lower than P25.00/bag of 50 kg.


3. Selling prices indicated herein are subject to change upon further notice.

- i. Barangay Food Terminal (BFT) has been renamed to Barangay Bagsakan (BB), and refers to community-based outlets in the depressed areas.
- ii. IBSP – formerly IBGP
