# CENTRAL OFFICE

#### **JOURNEY TO MODERNIZATION**

The NFA post harvest facilities (PHF) modernization under the Masagana Agri-Food Infrastructure Modernization (MAFIM) Program is now in full swing as the NFA successfully procured services and executed contracts in 2024.

NFA Administrator Larry R. Lacson, in a statement, said "Ito na ang umpisa ng matagal na nating hinihintay na pagbabago upang higit pang mapag-ibayo ang pagbibigay ng serbisyo sa ating bansa. At sa pagbabagong ito ay kaakibat natin ang ating mga kawani sa NFA at ang mga magsasakang Pilipino."

According to Dr. Mario G. Andrada, Officer-in-Charge - Deputy Administrator and Chairperson of the Central Office Bids and Awards Committee for the Establishment. Repair, and Rehabilitation of NFA Warehouses, the NFA now has thirtysix (36) warehouses planned for construction. It has also identified one hundred thirty-four (134)warehouse sites nationwide for repair and maintenance (RMT).



Members of the Central Office Bids and Awards Committee met for the preprocurement of infrastructure projects under the MAFIM.

As a way forward, the NFA management has already polished the terms of reference for drying and rice mill facilities. Likewise, plans and programs for more post-harvest facility installations, such as silos, are set.

"For 2025, the operations team has proposed the conduct of purity testing and contract drying/ testing and commissioning in identified field areas as we need to ensure that the quality of our goods passed the required standards. The agency will be capacitating its Engineers, Quality Assurance Officers, Pest Control Officers, and

Calibrators to upgrade, update, and facilitate the transfer of knowledge. This is to ensure that know-how on grains warehousing operations and facilities are linked and sustained," Dr. Andrada said.

The NFA has recently conducted **Ugnayan** activities with the leaders of farmer organizations and individual farmers in high supply procuring areas to gather their observations and recommendations to further improve the agency's strategic operations. This particular on the use of farmer sacks in place of the usual utilization of NFA empty sacks (MTS) for the agency to save on operational costs.

#### NFA MANPOWER PLACEMENT PROGRAM

Year 2024 is a big leap for the agency as its personnel complement under its restructured plantilla per Republic Act No. 11203, or the Rice Tarrification Law, undergoes empowerment.

Records from the Administrative and General Services Department's Human Resource Management Division states that for this year, the NFA has promoted two hundred ninety-eight (298) employees, hired eighty three (83), reappointed fourty seven (47), three (3) were employed, and transferred eight (8) while fourteen (14) has changed its item number.

To fast track the proceedings of the manpower pomotions natiowide. the NFA has conducted a series of briefings with the agency's field



executives and administrative officers to lay down the plans and steps on manpower promotion based on the revised Merit Selection Plan (MSP) approved by the Civil Service Commission (CSC).

In the conduct of promotions, the NFA Human Resource bases its actions with the MSP and the Omnibus Rules on Appointments and Other Human Resource Actions (ORAOHRA) and other pertinent related laws.

# NFA TO TRIM POWER COST FROM NEW SOLAR PROJECT WITH PNOC





The National Food Authority signed a Memorandum of Agreement (MOA) with state-owned Philippine National Oil Co. (PNOC) to implement a rooftop solar photovoltaic system at its office in Quezon City. This initiative aims to reduce electricity costs and improve overall energy management for the agency responsible for ensuring the country's rice supply.

"

NFA is going green. We will not only save on our power cost from this solar rooftop project, we are also contributing to the reduction of carbon emission and in safeguarding the environment," NFA Administrator Larry Lacson said. He added that the solar project that agency's head office will be eventually replicated in other NFA offices and warehouses across the country.

Under the agreement, NFA will lease a 100 kilowatt-peak solar PV system, which is projected to substantially lower its electricity expenses. The monthly billing will be calculated based on the net energy output of the solar system, set at a rate 10 percent lower than prevailing utility prices. This cost-saving measure is expected to provide NFA with significant financial relief, allowing it to allocate more resources toward its core mandate of maintaining sufficient rice buffer stocks. For the entire NFA network, the total solar capacity will be 5 MW.

The project aligns with PNOC's commitment to promoting renewable energy and self-sufficiet energy in government operations. By leveraging solar power, NFA not only reduces its carbon footprint but also contributes to the national goal of increasing renewable energy utilization. The collaboration represents a strategic investment in sustainability, which is crucial in the face of rising energy costs poised to enhance its energy efficiency, reduce operational costs, and solidify its commitment to environmental responsibility, all while ensuring that the country's rice supply remains secure and accessible to the Filipino people.

The implementation of the solar PV system comes at a time when government agencies are under increasing pressure to adopt more efficient practices. NFA's participation in this project sets a precedent for other government entities, demonstrating the viability and benefits of transitioning to renewable energy sources.

As NFA moves toward more sustainable operations, it strengthens its role as a leader in energy efficiency within the public sector.

In addition to cost savings, the project is expected to enhance the reliability of NFA's energy supply. By generating its own electricity, the agency can mitigate the risks associated with fluctuating energy prices and supply disruptions. This reliability is particularly important for NFA, as its operations directly impact the country's food security.

The MOA stipulates that ownership of the solar PV system will transfer to NFA after fifteen years at no additional cost, further enhancing the long-term benefits of this investment. This lease-to-own arrangement not only reduces upfront costs but also provides NFA with a sustainable energy solution for years to come.

The NFA will also benefit from the expertise and resources of PNOC throughout the installation and operational phases of the project. PNOC is responsible for ensuring that the solar PV system complies with safety standards and relevant regulations, allowing NFA to focus on its core activities without diverting significant resources toward energy management.

Overall, the partnership between NFA and PNOC marks a crucial step in modernizing the agency's operations and promoting sustainability. With this solar project, NFA is poised to enhance its energy efficiency, reduce operational costs, and solidify its commitment to environmental responsibility, all while ensuring that the country's rice supply remains secure and accessible to the Filipino people.

 ${f T}$ he Province of La Union anticipates an increase in rice production as the National Food Authority and the Provincial Union Government of La formalized partnership their through signed Deed а Usufruct on August 7, 2024, for the construction of a P200-million rice processing center.

The facility, which is part of the National Food Authority's plan to boost the national food security, will be built in Barangay Damortis, Santo Tomas, La Union and will feature state-of-the-art technology such as a modern rice mill, mechanical dryer, a 100,000-bag capacity warehouse, generator sets, three-phase power supply, electronic truck scale, and a staff house.

NFA Administrator Larry R. Lacson lauded the NFA La Union for its sufficiency with 152,000 metric tons of rice produced in a year. With La Union's current production rate of 4.5 metric tons (MT) per hectare, it surpasses the national production average of four (4) metric tons per hectare

Further, he also said that the establishment of a government-owned rice processing center or RPC will ensure efficient and sustainable processing of high-quality rice and boost the growth of the local rice industry.

La Union Governor Raphaelle Veronica-David, known for recognizing the farmers' livelihood as the "lifeblood of our society", thanked the NFA for recognizing the province's thrust on local agricultural productivity and vowed that her administration will continue to ensure maximum support to farmers and agri-entrepreneurs.  ${f N}$ FA Ilocos Norte through its Buffer Stock Management Unit has conducted sixteen (16) Ugnayan activities for the first quarter of 2024. The Ugnayan aims to inform the local farmers in the area about NFA's programs, projects and activities.

The NFA Warehouse Supervisors and Branch Standard Quality Assurance Officers (BSQAOs), during the Ugnayan, emphasized the importance of how the farmers' produce contributes to the realization of a sufficient buffer stock, ready to be distributed in times of calamities and/ or emergencies.

As a result of the said joint effort of NFA other DA-attached employees and agencies/institutions, various groups of farmers pledged to share a portion of their produce amidst the high buying prices of traders, which range from ₱24.00 to ₱28.00 per kilogram.

Said pledges started to materialize in the middle of March, wherein despite the government's buying price pegged at ₱23.00/kg, a total of two hundred seventy-nine (279) bags were procured from various individual farmers who shared a bag or two of palay and from farmers' organizations through field procurement within Ilocos Norte.

On December 16, 2024, the NFA, represented by Designated BIO Karen Isabel M. Bucaoto, attended the 2024 4th Quarter Cordillera Disaster Risk Reduction Management Council (DRRMC) Response and Early Recovery Pillar Meeting, held at the Ritz Hotel, Legarda Road, Baguio City.

The meeting agenda focused on the recapitulation of the year's agreements between the DRRMC & its Line Agencies. **Topics** discussed including proper coordination, effective communication, and timely. accurate response and updates during times of calamities or disasters.

A brief preview for the programs and activites for the CY 2025 were also presented.

The NFA is among the cooperators to the quick response via issuance of rice to the identified beneficiaries through the various relief giving agencies.

The NFA Isabela Branch Office. led by Acting Branch Manager Atty. Angelique D. Balisang, has achieved significant milestones in palay procurement for the first semester of 2024. With the procurement of 410,115 bags of palay, the branch has accomplished 95.38 percent of its target of 430,000 bags. The total procurement for the year 2024 stands at an impressive 456,672 bags or equivalent to 81.99 percent of the annual target. These accomplishments reflect the commitment and dedication of the NFA Isabela Branch in fulfilling its procurement objectives.

The Price Range Scheme, or PRICERS, is an innovative scheme that has empowered the agency to adopt flexible pricing mechanisms, enabling the NFA to procure more palay and accumulate buffer stock in its warehouses. The key factors contributing to the success of the implementation of the new Price Range Scheme (PRICERS) are attributed to the hard work of its employees.

#### **CAGAYAN PROCUREMENT ACCOMPLISHMENT**



he NFA Cagayan has achieved impressive milestone by surpassing its palay procurement target for the period from January to September 2024. The branch recorded a procurement rate of 105.91%, securing a total of 744,576 bags of palay, exceeding its target of 703,000 bags.

This outstanding performance not only highlights the branch's commitment to ensuring food security but also plays a crucial role in contributing to the region's buffer stock requirements.

A significant portion of this procurement, totaling 723,422.86 bags, was achieved through the PRICERS Program, which aims to support local farmers and improve procurement efficiency.

The NFA Cagayan Branch's success reflects its dedication to fulfilling its mission and providing reliable food supply management in the region.

The NFA Council on April 18, 2024 approved the implementation of the Price Range Scheme (PRICERS) for the NFA's Palay Procurement Activity as per Implementing Guidelines, which states that the effective buying price of palay per province shall be adjusted and approved on a weekly basis based on the prevailing ex-farm palay prices and other considerations. A weekly Buying Price Bulletin (BPB) will be followed, which refers to the composition of the newly approved NFA base support price for palay set at ₱23.00/kg for clean and dry and ₱17.00/ kg for fresh/wet palay plus PALLGU premium as applicable.

#### INSPECTION OF RICE DONATED BY MAFF-JAPAN

NFA Administrator Larry Lacson with Assistant Administrator for Finance and Administration Veralew DG. De Vera and Executive Assistant Attv. Maria Lucila Margarita P. Mangrobang conducted inspection on the quality of rice and palay stocks as well as the palay procurement operations in Ipil, Zamboanga Sibugay and in Zamboanga City on November 12, 2024 during their visit in the Region.

As of November 15, 2024 NFA Region IX's palay procurement is already up by 160% compared to the annual accomplishment in 2023. The region has already procured a total of 190,007 bags of palay, a significant increase from last year's 73,188 bags. The activity began with a pre-test for the participating employees followed by lectures on NFA Palay Procurement Program, SOP on Palay Corn Classification Coding System Procurement, Grain Anatomy and Variety Code, Inspection and Sampling During Procurement, ENW Factor, Operation, Care and Maintenance of Moisture Meter with Demo, Principles of Grain Drying, Milling and Storage, Physical Analysis Procedure for Palay and Milled Rice and Staining Solution, and Task and Responsibilities of Classifier. The day 2 lectures were composed of 10 Fundamental Standards on Stock Quality Maintenance and Good Warehousing Keeping Management, Flowchart of Quality Assurance from Procurement, laboratory workshops, and a Post Test. Speakers for the two-day seminar-workshop were RSQAO Lloyd Q. Son, BSQAO Kristine S. Araojo, Acting BSQAO Earl Abarri, Engineer III Terry Joy N. Pacas, and Engineer III Jeffry Rumbaua.

The participants received their Certificates of Completion. In his closing remarks, RM Jordan Valente highlighted the importance of Quality Assurance and the role of Classifiers in NFA Operations. He challenged the new set of Classifiers to be both passionate and firm on their grain classification activities in the future. #### **SECOND TIME PALLGU PARTNERSHIPS**

he NFA Region IX and the City Government of Zamboanga represented by City Mayor Hon. John M. Dalipe officially signed the Memorandum of Agreement (MOA) on the Palay Marketing Assistance Program for the Legislators and Local Government Unit (PALLGU) on February 28, 2024 at NFA Atrium, Zamboanga City.

The City Government of Zamboanga pledged a commendable amount of \$10 million, granting a \$5.00/kg premium to be added on top of the NFA's palay buying price. This marks the second PALLGU partnership between the City of Zamboanga and NFA, the first having been signed in early 2023. Due to the positive impact on local rice farmers, the City Government decided to continue the partnership with NFA Region IX this year.

Meanwhile, on March 8, 2024, at the Municipal Grounds in Kumalarang, OIC-Branch Manager Rogelio Antonio B. Lumo received from Mayor Ruel G. Molina a symbolic check for ₱2,000,000, which grants farmers a ₱5.00/kg premium to be added on top of NFA's palay buying price.

In 2023, Mayor Molina also entered into a PALLGU MOA with NFA Region IX, offering a premium of ₱3.00/kg. Following the positive feedback from Kumalarang's rice farmers, the Municipal Government decided to increase its support with a higher premium this year.

NFA Region IX also has two other PALLGU partnerships with the Provincial Governments of Zamboanga Sibugay and Zamboanga del Norte. / THEA ANGELIE G. ALAVAR

#### **RICE DISTRIBUTION TO EL NIÑO VICTIMS**

A total of 100 bags of NFA rice was released to the Local Government Unit (LGU) of Zamboanga City last, April 19, 2024.

#### **FARMERS BOOST PROFITS, USE NFA's FREE SUN DRYING PAVEMENT**

Rice farmers from Baungon and Talakag, Bukidnon, along with those from Villanueva and Claveria, Misamis Oriental, have found a simple yet effective way to increase their earnings by taking advantage of the free sundrying pavement provided by the National Food Authority (NFA) Misamis Oriental Branch Office in Baloy, Cagayan de Oro City.

Many of the rice farmers, access to affordable drying options can be a challenge, especially those with smaller farms. Renting drying equipment or finding space to dry palay at their own places is not always easy or cost-effective. The free sun-drying pavement at the NFA Balov Office has become a lifeline, helping farmers save on drying costs while ensuring their palay is in top condition for sale.

The convenience of drying the palay at the NFA facility, and then immediately selling it, has made a big difference in their operations, allowing them to focus on what they do best: growing rice.

#### LANAO NORTE PALAY PROCUREMENT BREAKS RECORD (Highest in Five Years)

Palay procured in NFA Lanao del Norte Branch as of July 2024 has already reached around 1,263.8 MT or equivalent to 25,276 bags.

The most came from the Province of Misamis Occidental followed by Lanao del Norte. Although the latter is bigger in terms of production volume, it can be recalled that GID 3 Warehouse in Ozamiz City had resumed its operations earlier and just in time for the on-going harvest in some areas of the province, while GID II-Lala Warehouse, Lanao del Norte reopened just in June, past the peak of the harvest season. Iligan City ranks third in the order of palay sources since its local production is only minimal making GID I- Bara-as warehouse mainly a central hub for rice distribution during emergencies and calamities.

Lanao del Norte's procurement accomplishment from January to July, 2024 has reached its highest level since 2020. The increase, attributed to the implementation of the Price Range Scheme (PRICERS) in April, represents 789% higher compared to the same period in 2023.

STOCK REPORTING: OIC -RM Rejorie R. Onde presented to Department of Agriculture (DA) the buffer stocking accomplishment of NFA during the DA Mid-year Assessment held in Malaybalay, Bukidnon on June 10, 2024.

The strategic design to set the NFA palay buying price at par with the prevailing farmgate prices have resulted in significant growth of palay reserves in NFA LNO. Noticeably, the PRICERS have boosted some farmers' financial capacity in terms of paying for delivery and labor costs as they would initiate to utilize their own manpower and logistics in the delivery of their palay to NFA. This made the NFA focus on picking up palay from other farmers whose resources are limited.

The second highest palay procurement record in 5 years was in 2021 bringing in 891.35 MT of palay to NFA which is equivalent to 17,827 bags.

The sustained attainment of procurement targets for CY 2024 has been made possible not only due to improved pricing scheme but of employees' dedication towards work and continued coordination with LGUs and Farmers' Organizations.

his year, the NFA Davao del Sur Branch Office has made remarkable progress in palay procurement. demonstrating its unwavering commitment to ensuring food security. Over 68,000 bags of palay have been successfully procured by the branch as of October, 2024, meeting an outstanding 74% of its yearly goal. This accomplishment highlights the effectiveness of the branch's strategies aimed at bolstering the government's rice inventory.

A significant factor contributing to this success has been the NFA Council's decision to raise the buying price for clean and dry palay to a range of ₱23.00 to ₱30.00, while fresh or wet palay is now priced between ₱17.00 and ₱23.00.

The branch has also undertaken intensified procurement efforts. This includes extensive information dissemination and active participation in farmers' meetings and assemblies.

The sun shone down on the Maguindanao, Basilan, and Lanao del Sur rice fields, casting its familiar warmth to the farmers as they harvested their crops.

This year, a new sense of optimism blossomed alongside the rice stalks, thanks to the initiative of the National Food Authority (NFA), which promised stability and fair compensation for the farmers' hard work.

For years, farmers in the BARMM had faced the uncertainty of fluctuating market prices, leaving their livelihoods vulnerable to financial hardships. The palay procurement program, implemented by the NFA, offered the much-needed solution. It provided a guaranteed market for their harvests, ensuring a fair price and a stable income, reducing the anxieties associated with unpredictable market conditions.

As farmers delivered their palay to designated collection points, relief washed over them. They could now focus on improving their farming practices, knowing their efforts would be rewarded.

The impact of the palay procurement program extended beyond the individual farmer. It ensured a buffer stock for the nation, and preventing drastic fluctuations that could threaten the food security that we ensure for the Filipino people. The procured palay replenished the NFA's buffer stock, a vital safety net in times of emergencies, crises or natural disasters as well as in sustaining the disaster relief program of our government.

However, the journey wasn't without its challenges such as limited storage capacity, logistical issues, and the need for continuous monitoring and evaluation presented hurdles. However, the government was actively addressing these challenges by expanding storage facilities, improving and providing logistics.

**O**n November 13-14, 2024, National Food Authority Administrator Larry R. Lacson, embarked on a mission to Tawi-Tawi, aiming to strengthen community partnerships and foster economic growth in the region.



## HIGHLIGHTS OF NFA'S 2024 ACCOMPLISHMENTS

#### **NFA INVENTORY**

As of December 31, 2024, the NFA rice stock inventory is at 5,697,094 bags of 50 kilograms (Total Expected Milled Rice Inventory or TEMRI) or 284,855 metric tons with a 95% accomplishment rate based of the required 300,000 MT or 6,000,000 bag optimal level of rice buffer stock. The government rice reserve being held by NFA is only part of the total domestic rice stock inventory of the entire country.

#### **PALAY PROCUREMENT**

The NFA, as of December 31, 2024, procured a total of 8,749,888 bags or 437,494.40 metric tons of of palay, representing 88.4% accomplishment rate of the CY 2024's palay procurement target of 9,900,000 bags or 495,000 metric tons. This is 7,181,509 (359,075.45 MT) or 558% higher than CY 2023 actual palay procurement of 1,568,379 bags (78,418.95 MT). The record-high procurement for CY 2024 was due to the implementation of the NFA Council approved Price Range Scheme (PRICERS) for palay procurement program. This scheme provides palay farmers with high government buying price set at competitive level, which is at par of above the prevailing ex-farm price. The Agency procured palay from local farmers nationwide, mostly from Central Luzon, Cagayan Valley, Southern Tagalog, Ilocos Region, and Western Visayas.

#### **DISTRIBUTION OF MILLED RICE**

As of December 31, 2024, the NFA released a total of 779,101 bags of 50 kg rice (38,955.05 MT) to the Office of Civil Defense (OCD), Department of Social Welfare and Development (DSWD), Local Government Units (LGUs), Legislators, Bureau of Jail Management and Penology (BJMP) and other government agencies.

Succeeding periods in its history have seen NFA MPC's viability and sustainability which was described and recognized in the 2023 Audited Financial Statements. As of December 31, 2023, the cooperative had 1,162 co-owners/members in good standing; with a total asset of P88.9M; a paid-up capital of P53.8M; and a net surplus of P1.9M with a total loan portfolio of P45M.

Adapting to the changing financial and economic trends and maximizing profitability, NFA MPC has invested its funds in shares of stocks, treasury bonds and time deposits to various institutions. Alongside investments, NFA MPC has strived to be true and faithful to its vision to provide excellent products and services towards stability and sustainability; to create opportunities for a better life.

Today, NFA MPC boasts an enviable status as a multi-awarded cooperative which affirm its influential and strong leadership in the industry, backed up and inspired by its 1,084 co-owners/members who continue to patronize and enjoy loan products, benefits and services that have been the result of constant forward planning or foresight matched by persistence. determination, dedication and commitment of its management.
